PLEASE READ CAREFULLY AND SIGN

- A contract of **three (3) months minimum** is required for Dry Stack and/or Land Storage. If the client decides terminate this contract before the stipulated minimum terms, the client will have to pay for the minimum term specified in the contract.
- Payments are due the first day of each month. *Varadero @ Palmas, Inc.* gives our customers a 9 days grace period after the due date; **after day 10 of each month a \$25.00 late fee charge applies.**
- A valid credit card on file (Visa and/ Master Card) is **required.**
- Pro rate applies only at the beginning of the contract, **if the client decides to leave before the end of the month; the monthly payment will not be refunded.**
- The owner will be responsible for notifying Varadero administrative office, **in writing with 30 days in advance,** the intentions to terminate this contract. If the customer fails to comply with this rule, Varadero will continue billing and collecting monthly until the receipt of such notice. **The amounts collected will not be refunded, nor will any credit be given.**
- All outside independent contractors hired by Varadero's clients to perform works on their boat **must be approved prior to any work performed by the administration of Varadero @ Palmas, Inc, and pay the corresponding landing fee.**
